## Section VII. Registration of acts of civil status

### Chapter 29

Family Code of the Republic of Uzbekistan (Entered into force on 01.09.1998)

#### Article 228

Amendments, corrections and additions to the civil status records, if there are sufficient grounds and in the absence of a dispute between the interested parties, are made by the civil registry offices at the location of these records, if they were compiled on the territory of the Republic of Uzbekistan.

Amendments to the books of records of birth, marriage, divorce of persons who have reached the age of sixteen are made at their request.

Changes to the birth record book for persons under the age of sixteen are made at the request of their parents.

Consideration of applications for correction of civil status records drawn up outside the Republic of Uzbekistan is carried out by the civil registry office at the place of residence of the applicant.

The conclusion of the body of registration of acts of civil status on the refusal to make changes, corrections, additions to the book of records of acts of civil status may be appealed in court.

#### Section 229. Making Corrections When Changing Sex

Correction of civil status records when changing gender is allowed only upon the conclusion of the health authorities.
